Please accept this nomination as a testament to the effectiveness, professionalism and quality of product given to RiverRidge Golf Complex by Rory Allison. Beginning in April of 2017, it has been our honor to continually introduce, without any reservation, Rory as our Golf Course Superintendent. We've enjoyed his participation in the Superintendents Association and the network he has built.

His assistant superintendent experience began in 2002 with course construction to opening of Kukio Golf and Beach Club on the big island of Hawaii. In 2005 he came back to the mainland to grow in and open Headwaters Golf Club in Idaho. The Big Island got him back in 2006 as Waikoloa Beach Resort's Superintendent and Director of Resort Operations until he joined us in Eugene, Oregon as our Golf Course Superintendent.

Since joining our company, Rory made immediate impacts on the quality of the turf, specifically the greens; the playability by raising canopies and opening the course for better flow for golfers.
