Chanaan join the Juniper team a little over a year ago. There were some challenges laid before him, day one. He walked onto a property that's known for having an enormous amount of scrutiny. During his first quarter on site, his assistant and mechanic took promotions moving to other facilities with in the region. The club was also in the process of receiving approval for a capital project repairing one of the ponds.

Chanaan took the challenges head on. Hire and trained an entire staff that included a new "green" assistant, a new mechanic, two returning seasonal EE, four new seasonal EE and started a partnership with Abilitree which brought two special needs EE onto the team as well. Chanaan also audited the 15 year old irrigation system, updated the IPM programs and fixed a troubled green. That produced a product that was touted as the "best conditions we've seen." I forgot to mention the capital project...through all the normal daily course set up routines, getting to know his property, improving conditions and training his staff. Chanaan's involvement and work with the capital project, he was able to save our client \$10K from the original capital budget.

Chanaan's conditions and set up of Juniper continues to receive high reviews from the tournament players throughout the region - be the OGA, OR Chapter PGA and/or PNW section of the PGA. Juniper is the facility in CO that everyone continues to choose year end and year out – for a personal round of golf, friend's weekend or local golf association. It's Chanaan's effort and attention to detail that brings everyone back.
