Jim Myers began at our Club on July 1, 2019.

Jim has excelled from day 1 at our Club. His first year included a mid-summer start, a week before our Member Guest tournament, followed by a hot summer and an LPGA Tour event just 2 months later.

In 2020, COVID hit and our rounds played have exploded to record levels. The golf course has been a safe haven for our members, to comfortably enjoy life outdoors, safely spaced and mask free. Jim and his team addressed the record rounds with increased patrols of divot filling, bunker raking, and ball mark fixing. And he has done it under budget each and every year.

He also has developed a 'bench' of assistants, in which we currently have 4 other staff members that are working towards Certification with the GCSAA.

In addition, Jim volunteers his time to assist with seminars for his peers, working with Sygenta and other manufacturers to provide engaging education opportunities for golf course industry professionals.
